Chairman Kavanaugh convened the meeting at 1:00 p.m. In attendance, confirmed by roll call were Arturo Carranza and Carlos Carranza (APC Pallets, Inc.); Pat Olstad, Justin Serfass and Shawn Puckett (Funko, LLC); Michael Varone (The Countertop Factory Southwest, LLC); Ryan Wurm (Thrive Climbing LLC): Anne Ryman (ABC15); and Lea Bartynski (Snell & Wilmer). Also in attendance on the telephone, confirmed by roll call was Suzy Braden (Encompass Health).

Mr. Atencio discussed ADOSH's inspection, summarized the citation and proposed penalty.

Chairman Kavanaugh checked if Funko would like to comment.

Mr. Serfass thanked the Commission for the opportunity to comment on their inspection. He noted a discrepancy, , they only have 14 shrink wrap machines and only 12 operational during the Funko is now doing in-house training going forward and have records of every employee that is currently trained and pivoted to all full-time employees on forklift equipment.

Mr. Serfass had some concerns about aspects of the inspection. The shrink wrap machines are an industry standard and were installed by the manufacturer. They have over 10,000 of those machines in Arizona and have installed them all without guard rails. He referenced the photographs that show tape around the machines and also you start the machine after you get away, so the machine is not running while you are next to it. You tie the shrink wrap to the pallet and get away and then go to the machine that also has an e-stop. They are not in any other place or separated or different railing around them, and most places you do not even see the tape on the floor, but they have done that.

Mr. Serfass commented that they come in good faith, safety is their top priority. They have collaborated very well with the department from the first and second visit and after to make sure they have cleaned up their training and put some guardrails in place so the training materials cannot get deleted or stolen.

Commissioner LeMarr asked about the manufacturer's specifications to safety, especially around the cutting blade.

Mr. Olstead responded noting they reached out to the manufacturer, and they stated the designation they have for safety when they applied for their patent was acceptable and need to have it notated, but because the moving part seals itself into a hidden slot it was not deemed to require any guarding around that, and that is why none have guards unless there is a conveyor attached to it with moving parts.

Mr. Atencio, Chairman Kavanuagh, Vice-Chair Hennely and Commissioner LeMarr discussed the various concerns raised by Funko.

Commissioner LeMarr moved to remand back to ADOSH for further review and Vice Chair Hennelly seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly and Commissioner LeMarr voted in favor of the motion. The motion passed.

Mr. Atencio noted the Mr. Wurm did not have any employees at the time of the inspection but did have at least one employee during the six months prior to inspection. Mr. Atencio discussed ADOSH's inspection, summarized the citation and proposed penalties.

Mr. Wurm requested to speak. He provided some background on his company. He noted the learning process of the investigation and the specialized equipment that did not have guarding. He shut everything down for about two weeks and focused on fabricating guarding and making sure everything is safe. He provided ADOSH pictures of the fixes for the new wiring and fabricated guards.

Chairman Kavanaugh thanked Mr. Wurm for his comments and the work to take corrective action.

Vice Chair Hennelly thanked Mr. Wurm for coming down and asked from his perspective were all of the concerns been abated. Mr. Wurm noted there was only one item, which he is still addressing.

Vice Chair Hennelly thanked Mr. Wurm and noted it sounded like he was well on his way.

Commissioner LeMarr moved to amend the citation and proposed penalties. Because of the very strong effort to abate the issues, noting this Commission really cares about abating job site hazards and appreciate that, he suggested at 25% Good Faith Discount for the abatement efforts for a total of \$4,018.00. Vice Chair Hennelly seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly and Commissioner LeMarr voted in favor of the motion. The motion passed.

Mr. Atencio noted this was a unique inspection since there are no longer employees the employer did not have to abate anything but he abated the safety concerns nonetheless.

Chairman Kavanaugh noted the Commission appreciates his efforts.

# Announcements, Scheduling of Future Meetings and Retirement Resolutions.

Chairman Kavanaugh commented on his virtual attendance at the IAIABC Alternate Dispute Resolution Committee meeting and are looking for Judges for Zehmer Moot Court Competition on July 28<sup>th</sup>; Ombudsman's Training Session on August 10<sup>th</sup>; and October 11<sup>th</sup> is their Dispute Resolution Committee Meeting which may be an interest to the ALJ Division; and there will be a Mediator College Program to start around January 2024.

Chairman Kavanaugh and Mr. Ashley noted that they appreciated Ms. Braden sending the additional information about their company's safety week and other efforts and the information has been distributed.

Mr. Ashley updated the Commissioners on the heat stress awareness campaign for this year and the importance of recognizing heat stress and efforts for employers and employees to take to alleviate the hazard and shared the new public service announcement videos that will be running through the summer.

Ms. Dimas confirmed Commission meeting dates through August 2023.

Mr. Ashley noted August 11<sup>th</sup> is the traditional meeting on the second day of the two-day Claims Seminar. Chairman Kavanaugh noted he will be in Tucson that day and could probably participate by telephone.
