## Approval of Minutes of August 17, 2023 Regular Meeting Minutes.

Commissioner Valdez moved to approve the Minutes of the August 17, 2023 regular session meeting and Commissioner Everett seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett and Commissioner Valdez voted in favor of the motion. The motion passed.

## Consent Agenda:

All items following under this agenda item are consent matters and will be considered by a single motion with no discussion unless a Commissioner asks to remove an item on the consent agenda to be discussed and voted on separately. The Commission may move into Executive Session under A.R.S. § 38-431.03(A)(2) to discuss records exempt by law from public inspection. Legal action

involving a final vote or decision shall not be taken in Executive Session. If such action is required, then it will be taken in General Session.

Commissioner Everett moved to approve the items on the Consent Agenda and Commissioner Valdez seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett and Commissioner Valdez voted in favor of the motion. The motion passed.

Discussion and Action regarding the 2023/2024 Arizona Physicians' and Pharmaceutical Fee Schedule.

Mr. Carpenter thanked the Commission for the opportunity to present the final staff recommendations for the 2023-2024 Physicians' and Pharmaceutical Fee Schedule. Mr. Carpenter also thanked the many stakeholders who have provided input and feedback that was used to improve and update the Fee Schedule this year. Most of the updates in this year's Fee Schedule were based on recommendations initiated by stakeholders and public comments.

First, staff recommends including the updated service codes, relative value units (RVUs), and reimbursement values as presented in the tables accompanying the published final draft. This year, staff recommends using values from FAIR Health to establish the RVUs assigned to "gap" codes. Previously, we have used values from Optum to assign RVUs to "gap" codes. Staff analyzed the methodology used by FAIR Health to establish those values and believe their values better align with actual market values. The methodology used in calculating the final reimbursement values is outlined in detail in the published final recommendations. Staff did not use any values from the Office of Workers' Compensation Program in establishing RVUs and removed the reference to that step in this year's recommendations. The recommended 2023/2024 Fee Schedule will continue to use the Centers for Medicare and Medicaid Services, or CMS's, surgical global periods, assign RVUs to consultation services, and delineate codes that are unique to Arizona.

Staff recommends updating the RBRVS conversion factors used in the 2023/2024 Fee Schedule by increasing the conversion factor for Surgery services to \$72 and the conversion factor for Pathology, Medicine, Physical Medicine and Rehabilitation, and Evaluation and Management Services to \$68.

Second, staff recommends adopting the service codes and reimbursement values as presented in the Healthcare Common Procedure Coding System, or HCPCS, table accompanying the published final recommendations. The reimbursement values are based on the reimbursement values published by the CMS in the April 2023 Medicare Durable Medical Equipment, Prosthetics, Orthotics, and Supplies Fee Schedule. Staff recommends maintaining separate values for rural and nonrural areas and utilizing the methodology established by CMS to designate rural and nonrural areas in Arizona. HCPCS codes that did not have a value assigned by CMS were assigned a reimbursement value based on data from FAIR Health with the exception of miscellaneous codes. The values were then multiplied by a conversion factor of 1.4 resulting in the reimbursement values listed in the final recommended table.

Staff initially proposed to adopt a dental fee schedule in this year's update. Unfortunately, this requires the procurement of certain contracts that to date have not been fully executed. As such, we do not recommend adopting a dental fee schedule at this time. Staff will continue to work with all the parties with the intent to have a fully executed contract in place prior to the next fee schedule update.

Third, staff recommends continuing to designate Medi-Span® as the source to reference Average Wholesale Price (AWP).

Fourth, staff recommends adopting the deletions and additions to the 2023 edition of the American Medical Association's Current Procedural Terminology publication, also known as the CPT®.

Fifth, staff recommends adopting the revisions in each section of the Fee Schedule Guidelines that remove references that were already named in the Introduction Section and update the language regarding Arizona specific codes to improve clarity. Staff also recommends adding the HCPCS and Home Healthcare Guidelines as new sections of the Fee Schedule.

Sixth, staff recommends amending the Introduction Section of the Fee Schedule by removing the reference to the 1995 and 1997 Documentation Guidelines and replace the documentation standard with the American Medical Association's Evaluation and Management Code and Guideline Changes and the Guidelines for Evaluation and Management Services in the current CPT® publication. Staff recommends removing the reference to Optum 360, The Essential RBRVS and adding language that incorporates by reference FAIR Health data to assign RVUs to "gap" codes. Staff also recommends adding language to Subsection (A)(14) that clarifies the use of appropriate modifiers and place of service codes. Additionally, staff recommends amending Section B by adding the updated documentation standards in Subsection (B)(9). Staff recommends updating the language in Subsection J(4) to reference the appropriate manner to bill and reimburse supplies and materials given the adoption of the HCPCS codes.

Seventh, staff recommends adding language to Section C of the Anesthesia Guidelines that clarifies billing procedures.

Eighth, staff recommends adding modifier "59" to the Surgery Guidelines and additional language to modifier "AS" that clarifies appropriate reimbursement when the modifier is billed.

Ninth, staff recommends deleting HCPCS codes U0001 and U0002 from the Pathology and Laboratory Guidelines. These codes were developed in response to the COVID-19 Public Health Emergency and are no longer in use.

Tenth, staff recommends adding Section F to the Medicine Guidelines to clarify the codes that are to be used for Moderate Sedation based on the provider who performs the service.

Eleventh, staff recommends adding language to the Physical Medicine and Rehabilitation Guidelines that clarifies and emphasizes the documentation expectations for healthcare providers who bill for these services. This language was added based on reimbursement issues brought to our attention. Staff also recommends updating the language in Section D to reference the amended instructions in the Introduction Section on billing and reimbursing materials and supplies.

Twelfth, staff recommends adding the descriptions for the Arizona Specific Codes to the Special Services Guidelines and include documentation expectations when codes AZ003 and AZ004 are billed by healthcare providers. Staff also recommends the deletion of Arizona Specific Code AZ044. This code is no longer necessary since there are CPT® codes that should be used when services are provided outside of regular business hours.

Thirteenth, staff recommends adding billing and reimbursement guidelines on impairment examinations. This addition takes into consideration any additional time spent performing the service for complex cases. This change was not in the original proposal. The concern was brought to the attention of the Medical Resource Office in the time period following the publication of this year's proposal. Staff met with multiple healthcare providers and payers prior to adding this language to the recommended update. All of the feedback we received was positive and stakeholders unanimously felt that it represents an improvement in the Fee Schedule. Staff also recommends updating the Evaluation and Management Guidelines to correspond with the updates to the Evaluation and Management Guidelines in the 2023 CPT® publication.

Finally, staff recommends updating the Special Services Code Table to reallocate the CPT® codes that were previously included in this section to the Medicine Codes Table. This update aligns with the format of the current CPT® publication.

The Medical Resource Office recommended the Commission adopt the proposed revisions to the Pharmaceutical Fee Schedule as presented.

Chairman Kavanaugh thanked Mr. Carpenter and noted it is a complex and complicated process and thought he demonstrated an amazing level of patience and attention to detail and the Commission appreciates that.

Chairman Kavanaugh asked if there were any questions or comments, hearing none.

Commissioner Everett moved to approve staff recommendations to approve the 2023/2024 Fee Schedule as presented approve the Resolution of Authorization and Vice Chair Hennelly seconded the motion. Chairman Kavanaugh commented that the Commission appreciates all of the input from the stakeholder communities and the tremendous, detailed work from staff, this is an annual exercise that sometimes defies imagination. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett and Commissioner Valdez voted in favor of the motion. The motion passed.

Discussion and Action regarding Proposed Retaliation Penalty.
