Chairman Kavanaugh convened the meeting at 1:06 p.m. In attendance, confirmed by roll call were Stephanie Hefner (Snell and Wilmer); Matt Arndt and Carlos Salcido (Universal Chain); James Jagelski (Five Guys Services LLC Dba Five Guys Roofing); Anne Snell (self); Bob Khun and Tom Safranek (Flagstaff United School District -Coconino); and Cynthia Cruz and Nelsen Cruz (Cruz Framing). Also in attendance on the telephone, confirmed by roll call were Lora Figgat and Steve Montero Corrales (Intel Corporation), Monique Handy (Pinnacle West Capital Corporation); and Stephanie Guthrie (OnTrac Logistics, Inc.).

Chairman Kavanaugh noted that OnTrac Logistics, Inc., which is on the Consent Agenda would be moved off of the Consent Agenda to be discussed separately at the request of Ms. Guthrie.

Discussion and Action regarding Proposed Retaliation Penalty.

1. RT-2324-0105 Southwest Airlines Co.

Ms. Spurgeon summarized the Labor Department's investigation into the Earned Paid Sick Time (EPST) Retaliation claim. Ms. Spurgeon recommended that the Commission approve issuance of a Penalty in the amount of \$10,650.00 for violation of A.R.S. § 23-364.

Chairman Kavanaugh asked if the Commissioners had any questions.

Vice Chair Hennelly moved to approve issuance of a Penalty for Retaliation in the amount of \$10,650.00 to Southwest Airlines Co. Commissioner Valdez seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett and Commissioner Valdez voted in favor of the motion. The motion passed.

2. RT-2324-0123 Southwest Airlines Co.

Ms. Spurgeon summarized the Labor Department's investigation into the Earned Paid Sick Time (EPST) Retaliation claim. Ms. Spurgeon recommended that the Commission approve issuance of a Penalty in the amount of \$7,500.00 for violation of A.R.S. § 23-364.

Commissioner Valdez moved to approve issuance of a Penalty for Retaliation in the amount of \$7,500.00 to Southwest Airlines Co. Commissioner Everett seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett and Commissioner Valdez voted in favor of the motion. The motion passed.

Discussion and Action regarding Appointment of Special Assistant to the Industrial Commission of Arizona.

Suzanne Crifase

Ms. Standifird introduced Ms. Crifase and highlighted her background and experience. She requested a Resolution appointing Ms. Crifase as a Special Assistant with the Compliance Team.

Vice Chair Hennelly moved to appoint Ms. Crifase as Special Assistant and Chairman Kavanaugh seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett and Commissioner Valdez voted in favor of the motion. The motion passed.

Discussion and Action of Arizona Division of Occupational Safety and Health Proposed Citations and Penalties.

Chairman Kavanaugh discussed the purpose of and process for the Commission's consideration of ADOSH citations and proposed penalties.

Chairman Kavanaugh commented that OnTrac Logistics, Inc. will be first since it was removed from the Consent Agenda.

Mr. Hudson discussed the anonymous complaint, ADOSH's inspection, summarized the citations and proposed penalties.

Chairman Kavanaugh checked if Ms. Guthrie had any questions or comments for the record.

Ms. Guthrie noted OnTrac was caught by surprise to be here today. They got notice from local counsel of this item being included on today's Consent Agenda and there is actually not a matter in their file with the file number listed on the Consent Agenda. She was hoping to get a little more understanding of what this matter relates to. They had an inspection in December of 2023 and there was not a closing conference following that inspection, they received a document request via email without a reference number attached to it, and then responded to that document request later in December 2023. That was the last time they heard about the matter in December 2023. OnTrac wants to know how they are here today and also wondering about the closing conference.

Mr. Hudson noted according to the report from the Compliance Officer, a closing conference was completed on December 4, 2023 at 3:00 p.m. with Mr. Clarke, Mr. Montes, Mr. King and Mr. Rolling, and conducted inside Mr. Montes' office located inside the distribution warehouse facility in Phoenix, Arizona.

Ms. Guthrie asked if there was an address for the location.

Mr. Hudson noted he could provide an address for where the inspection took place, but did not have an address for the closing conference.

Mr. Hudson noted the address of the facility is 7400 W Buckeye Road, Phoenix, Arizona 85043.

Ms. Guthrie asked for the date of the closing conference again.

Mr. Hudson noted it was December 4, 2023 at 3:00 p.m.

Ms. Guthrie noted the response that they have to the document request was submitted on December 12, 2023, which appears to be after the date of the closing conference and looks the inspection was on December 4 for the initial walk around.

Mr. Hudson confirmed the date of inspection of December 4, 2023.

Chairman Kavanaugh asked if there could possibly be a request for records from the employer to come back to ADOSH after the inspection and closing conference?

Mr. Hudson noted he would have to find out more information on that, the inspection took place and looks like the closing conference took place on the same day.

Chairman Kavanaugh asked if there would be any issue for the Commission to defer this matter to a subsequent Commission Meeting just to make sure that the employer has the information on why the case is before them today? Noting the Commission as to watch the six months.

Mr. Hudson noted there should not be a problem.

Chairman Kavanaugh noted the other option would be approve the citation, obviously the employer could request an informal conference with you to sort out the issues that gave rise to the citations.

Mr. Hudson agreed.

Chairman Kavanaugh asked the Commissioners what their preference was.

Vice Chair Hennelly noted there is the May 30, 2024 meeting and could fit it in. He did not have a problem deferring to that date, but it would have to be that day.

Chairman Kavanaugh announced the case would be deferred to May 30, 2024.

Mr. Hudson and the Commissioners agreed. Chairman Kavanaugh thanked Ms. Guthrie for her comments and we will continue to work through the process.

They got a hold of the company to see if one is made and they do not. That machine has been there for years and there is not a guard on it like that and he wanted to address that. They aggressively looked and the machine has been locked since then, but there is no guard on that particular machine.

Chairman Kavanaugh thanked Mr. Khun for his clarification and confirm it was from the manufacturer.

Vice Chair Hennelly asked how the employee is doing after the injury and if he was back to work.

Mr. Khun noted the employee did come back to work, he was out for four or five days and then came back. He was a retired teacher and helps out and taught industrial for a number of years.

Vice Chair Hennelly moved to approve the citation and proposed penalties as presented and Commissioner Valdez seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett and Commissioner Valdez voted in favor of the motion. The motion passed.
