Mr. Hudson discussed ADOSH's inspection, summarized the citation and proposed penalty.

Commissioner Godfrey commented that the Commissioners' hearts go out to the employee and the family. This was a tragic and unnecessary accident, and Commissioner Godfrey looks forward to the next few months when the Commission discusses adopting pending OSHA response standards to hopefully prevent future accidents like this. The investment in our public safety must be a priority for our municipalities and our districts.

Commissioner Everett noted the report says life threatening injuries and asked if there was an update on the injured workers' condition. Mr. Parish stated it was a dire situation and he almost died.

Chairman Kavanaugh has worked with fire service extensively and it is disturbing that this accident happened and safety does need to be a priority not just for other employees but for the first responders and this case is almost a perfect example of why we want to get local cities and towns to work with the Commission to be part of our consultation program to have the consultation officers come out and evaluate the safety of their stations. Record keeping is important too, but inspecting equipment like this should be part of the regular course and scope of every shift that comes on. It is troubling that this has happened.

Commissioner Valdez feels bad for the family and for everyone that has suffered from this, it was unnecessary and hopefully we can do something to prevent that with consultation and find out how amazing that is for everyone to have that opportunity to do that.

Chairman Kavanaugh checked if anyone would like to comment.

Commissioner Godfrey moved to approve the citation and proposed penalties as presented and Commissioner Everett seconded the motion. Chairman Kavanaugh, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.

Commissioner Valdez moved to appoint Ms. Handy as Administrative Law Judge and Commissioner Everett seconded the motion. Chairman Kavanaugh, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.
