a) Gypsum reclaim grinder: A Vestil Manufacturing Corp. brand jib crane, model WTJ-4 series and unknown serial number, was used to lift a grinder lid which was in excess of the rated capacity and the usable reach of the lifting device of the crane. A.R.S. 23-403.A *Per ADOSH Director causal factor.

SERIOUS – Citation 1 - Item 2 –

a) Gypsum reclaim grinder: A 10 foot 6-inch-long alloy steel chain sling used with the Vestil Manufacturing Co. brand jib crane to lift the lid on the Williams brand grinder did not have an identification affixed to the sling. 29 CFR 1910.184(e)(1)

Commissioner Godfrey and Mr. Murphy discussed that there was not a size adjustment for Item 1 because it was the causal factor for the accident.

Chairman Kavanaugh and Mr. Murphy discussed the difference between the two citations and the causal factor.

Chairman Kavanaugh checked if anyone would like to comment.

Commissioner Godfrey moved to approve the citation adopting Commissioner Everett's 15% reduction for both items in light of the employer's corrective action, for a total penalty of \$18,612.00.

Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett and Commissioner Godfrey voted in favor of the motion. The motion passed.

Announcements, Scheduling of Future Meetings and Retirement Resolutions.

Chairman Kavanaugh complimented staff on the hard work for putting on the annual Claims Seminar, it was one of the best he has attended. He was pleased with the attendance and with the number of sponsors.
