Mr. Hudson discussed ADOSH's inspection, summarized the citation and proposed penalty.

Chairman Kavanaugh noted he had a request to speak Earl Williams.

Mr. Williams, President of Qualitas Machining & Automation, noted this was the first time Qualitas Machining has been cited, the company is about a year old, and they were not fully aware of all the requirements or as diligent as they should have been, but now they understand what is expected. They immediately took steps to address all the issues cited. The steps included installing an eyewash station, training employees on proper use of the eyewash station, instituting policies and updating the training on the forklift, requiring current certification for anyone who may use the forklift, implementing policies and training on respirators as well as identification and labeling of hazardous chemicals. They have proper fit testing and are in the process getting the medical evaluations for using the respirators.

Mr. Hudson commented that ADOSH works in a partnership with companies and organizations with the overall goal of preventing fatalities from occurring and ensuring everybody goes home at the end of the day.

Commissioner Everett and Mr. Hudson discussed that the next steps have been explained as the process goes forward.

Commissioner Valdez asked if a shower has been added. Mr. Williams noted they are in the process of putting in the shower.

Vice Chair Hennelly moved to amend the citation and proposed penalties with a 10% reduction given the abatement as described, given the understanding that there could be further discussion with ADOSH moving forward. Commissioner Valdez seconded the motion.

Chairman Kavanaugh appreciated Qualitas coming to the meeting and being candid with the efforts taken. Our goal is not to punish but we do have to enforce our laws and rules but will work with employers to minimize the risk of future incidents and violations.

Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett and Commissioner Valdez voted in favor of the motion. The motion passed.
