Mr. Hudson discussed ADOSH's inspection, summarized the citation and proposed penalty.

Chairman Kavanaugh commented that the company has been in business for 21 years without any serious injuries despite the variety of dangerous situations. It is disappointing to see the depth of the situation.

Commissioner Valdez moved to approve the revised citation and proposed penalties of \$17,285.00 and Vice Chair Hennelly seconded the motion.

Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.

Ms. Dimas confirmed Commission meeting dates through November 2024.

Mr. Testini commented that the agency joins the Governor's Office and other state agencies in lighting our building purple for the month of October in recognition of Domestic Violence Awareness.

Chairman Kavanaugh commented that the Administrative Law Judge Division is in the process of interviewing two Judge positions in the Tucson Office, one for a new position and one for a Vice Chief ALJ.
