Chairman Kavanaugh convened the meeting at 1:06 p.m. In attendance, confirmed by roll call were Taylor Thomas (Snell and Wilmer); Lindsey Wheeler (Premier Risk Management); Guadalupe Matadamas (Positive Spray Foam LLC); and Michael Andersen and Lorena Sanchez-Zumph (City of Glendale). Also in attendance on the telephone, confirmed by roll call were Nitra Hawkins (City of Mesa); Nichole Gonzalez (City of Tempe); Carolyn Horton and Uyen Nguyen (Costco Wholesale Corporation).

Chairman Kavanaugh commented on his two-year anniversary with the Commission. He noted there were a few adjustments on today's Agenda, the City of Phoenix self-insurance renewal would be moved to the May 1st Agenda. The Youth Labor cases would be removed from the Consent Agenda and will be presented individually. He also noted that three ADOSH matters were

removed from today's Agenda for further review the two Diversified Roofing, LLC files and Wood Framing, LLC.

# Approval of Minutes of April 10, 2025 Regular Meeting Minutes.

Commissioner Valdez moved to approve the Minutes of the April 10, 2025 regular session meeting and Commissioner Everett seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.

As noted previously, the City of Phoenix self-insurance renewal will be moved to May 1st Agenda. The Youth Labor cases would be removed from the Consent Agenda and will be presented individually.

Commissioner Godfrey moved to approve the remaining items on the Consent Agenda and Commissioner Everett seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.

Discussion and Action of Proposed Youth Employment Penalty.

#### 1. YL-2425-0038 Fred's Arena Bar & Steakhouse LLC

Ms. Spurgeon summarized the Labor Department's investigation into the youth employment claim. Ms. Spurgeon recommended that the Commission approve issuance of a Civil Penalty in the amount of \$1,000.00 for violation of A.R.S. § 23-236(A) and (B) and A.A.C. R20-5-905.

Chairman Kavanaugh and Ms. Spurgeon discussed the new hindrance rule, noting it is rare for an employer to refuse our investigation and because they hindered the investigation staff does not have information to determine what the youths were doing. They also discussed that Labor Department is implementing as part of their process a check to make sure the company has workers' compensation insurance. This employer does have a valid policy.

Vice Chair Hennelly and Ms. Spurgeon discussed the investigation into the potential violation will continue if this penalty is approved.

Vice Chair Hennelly moved to approve issuance of a penalty in the amount of \$1,000.00 to Fred's Arena Bar & Steakhouse LLC. Commissioner Valdez seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.

# 2. YL-2425-0035 Kennelly Family Concepts, Inc.

Ms. Spurgeon summarized the Labor Department's investigation into the youth employment claim. Ms. Spurgeon recommended that the Commission approve issuance of a Civil Penalty in the amount of \$600.00 for violation of A.R.S. § 23-233.

Chairman Kavanaugh and Ms. Spurgeon discussed issuing a penalty for one instance even though there were 99 incidents. Chairman Kavanaugh suggested at some point explore modifying the statute.

Chairman Kavanaugh asked if the Commissioners had any questions.

Commissioner Everett moved to approve issuance of a penalty in the amount of \$600.00 to Kennelly Family Concepts, Inc. Commissioner Valdez seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.

#### 3. YL-2425-0048 Makai Corporation

Ms. Spurgeon summarized the Labor Department's investigation into the youth employment claim. Ms. Spurgeon recommended that the Commission approve issuance of a Civil Penalty in the amount of \$700.00 for violation of A.R.S. § 23-233.

Chairman Kavanaugh and Ms. Gooby discussed the employer's comment for defense or excuse.

Chairman Kavanaugh asked if the Commissioners had any questions.

Commissioner Godfrey moved to approve issuance of a penalty in the amount of \$700.00 to Makai Corporation. Vice Chair Hennelly seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.

Chairman Kavanaugh commented he appreciated having the discussion seeing the trend across the country and appreciates the work the Labor Division does to continue to get the word out to so many of these industries and looking into the structure of the penalties.

Discussion and Action regarding Proposed Retaliation Penalty.

1. RT2425-0104 Primp and Blow Waterfront, L.L.C.

Ms. Spurgeon summarized the Labor Department's investigation into the Earned Paid Sick Time (EPST) Retaliation claim. Ms. Spurgeon recommended that the Commission approve issuance of a Penalty in the amount of \$20,844.66 for violation of A.R.S. § 23-364.

Chairman Kavanaugh asked if the Commissioners had any questions.

Commissioner Valdez moved to approve issuance of a Penalty for Retaliation in the amount of \$20,844.66 to Primp and Blow Waterfront, L.L.C. Commissioner Godfrey seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.

Discussion and Action of Arizona Division of Occupational Safety and Health Proposed Citations and Penalties.

Chairman Kavanaugh discussed the purpose of and process for the Commission's consideration of ADOSH citations and proposed penalties.

Chairman Kavanaugh noted he did not have a request to speak.

Commissioner Godfrey moved to approve the citation and proposed penalties as presented and Commissioner Valdez seconded the motion. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.

Discussion and/or Action regarding the consideration of candidates for appointment to the position of Administrative Law Judge pursuant to A.R.S. § 23-108.02(A). The Commission may move into Executive Session for the purposes described in A.R.S. § 38-431.03(A)(1) and (A)(3).

Judge Campbell noted this appointment is for the Phoenix office and there is a current posting for another positions. Judge Campbell recommended candidate number one for appointment.

Chairman Kavanaugh agreed and appreciated all of the work and assessments by the interviewing panel.

Vice Chair Hennelly moved to accept Judge Campbell's recommendation to extend an offer to candidate 1. Commissioner Everett seconded the motion. Chairman Kavanaugh noted this is not an easy task and these are important jobs in a competitive market. Chairman Kavanaugh, Vice Chair Hennelly, Commissioner Everett, Commissioner Valdez and Commissioner Godfrey voted in favor of the motion. The motion passed.

# Announcements, Scheduling of Future Meetings and Retirement Resolutions.

Ms. Dimas confirmed Commission meeting dates through June 2025.

Mr. Carpenter updated the Commissioners noting that bill 1551 was signed by the Governor, and the others are still at the Legislature and have not passed on.

Mr. Carpenter commented April 28, 2025, is International Workers' Memorial Day, the ICA will be recognizing employers that have been doing exceptional work within the workers' compensation, and ADOSH space.
