Commissioner Everett was a little concerned and surprised by the number of municipalities whose experience modification ratings exceeded the standard and who were asking for consultation services. The municipalities should be setting an example. While one municipality completed a root cause analysis the others did not.

Ms. Pastor explained that the municipalities almost always have an inflated experience modification because of the public safety units. Additionally, root cause analysis has determined that most of their risk is due to unpreventable incidences.

He shut down and ceased doing business during the investigation, retrained all employees, and has dedicated more of his time and energy to the safety of his employees by downsizing and reducing production.
