Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the Arizona Division of Occupational Safety and Health (ADOSH) Advisory Committee and to the general public that the ADOSH Advisory Committee will hold a meeting open to the public on **Wednesday, February 4, 2026, beginning at 10:00 a.m.** in the Auditorium at 800 West Washington, Phoenix, Arizona. Members of the Advisory Committee will attend either in person, by telephone conference call, or by video conference. The Advisory Committee may vote to hold an Executive Session for the purpose of obtaining legal advice from the Industrial Commission of Arizona's attorneys on any matter listed on the agenda pursuant to A.R.S 38-431.03(A)(3). The Executive Session is not open to the public. This agenda is subject to change up to 24 hours prior to the meeting. The Advisory Committee Chair reserves the right to change the order of the items on the agenda on the agenda, except for matters set for a specific time.

Pursuant to A.R.S. § 38-431.01(H), action taken as a result of public comment must be limited to directing ADOSH staff to study the matter, responding to any criticism, or scheduling the matter for further consideration and decision at a later date.
