Pursuant to A.R.S. §§38-431.03(A)(3), (4), and/or (7), the Committee may meet in Executive Session to discuss any of the following items. The Executive Session is not open to the public. This agenda is subject to change up to 24 hours prior to the meeting. The Committee Chairman reserves the right to change the order of the items on the agenda, except for matters set for a specific time.

Members of the Committee are not legally permitted to discuss or take legal action on any matter not specifically identified on the agenda, including matters raised in public comments. Pursuant to A.R.S. § 38-431.01(H), action taken as a result of public comment must be limited to directing staff to study the matter, responding to any criticism, or scheduling the matter for further consideration and decision at a later date.
