We are pleased to announce the rollout of the Industrial Commission's (ICA) new web site. The new site is much improved over the old and contains information that the public should find useful.

ADOSH Consultation Services In High Demand

When was the last time you talked to someone who told you they actually invited OSHA into their facility? Chances are not for awhile. I am proud to say that is changing. ADOSH frequently receives questions via e-mail, many of which are submitted through federal OSHA's web site. The following represents a sampling of those questions and the answers provided.

Question: Are Arizona workers allowed 15 minute breaks after four hours of duty?

Answer: There is no Arizona law requiring that employers provide a break period, or even a lunch period.

Question: Is it legal for my employer to lock the bathroom doors and require the employees to locate a supervisor and request a key?

Answer: OSHA standards require that toilet facilities be made available and ADOSH has interpreted this to mean that an employer must provide the facilities and allow employees to access them when

needed. Requiring employees to first obtain a key would be ok, so long as there is no barrier to obtaining it. In other words, the key must be made available upon request.

Question: Do you have Spanish standards books? Can you direct me to where I might obtain a standards book in Spanish?

Answer: ADOSH does not have Spanish standards books. You may be able to obtain a Spanish book from Puerto Rico, which operates an approved OSHA program. Their contact information can be found at www.dtrh.gobierno.pr/osho.asp.

Question: Is there a law against an employee having a pet on the premises? One of the owners keeps a dog here in the office and I don't like it licking me, biting my clothes or

jumping on me.

Answer: There is no OSHA regulation prohibiting the owner from keeping his pet on the premises. The best solution may be for you to speak with the owner and try to come to a workable solution.

Question: What are the immunization requirements for employees who clean toilets on a daily or almost daily basis?


Answer: OSHA standards require employees who are exposed to blood or other potentially infectious materials to be offered the hepatitis B vaccination. As a point of clarification, under the OSHA standard, urine and feces are not considered potentially infectious materials unless they contain visible blood.

Question: I am in Phoenix, Arizona. When the air conditioning is broken in an office building, how hot can it get before they should send employees home? (Or any number of variations on this same theme.)

Answer: There are no OSHA standards dealing with temperature in the workplace and thus no requirements that employers allow employees to go home if the temperature exceeds a certain level.

Question: The chemicals I use are having an effect on my hands and wrists. I never had a problem before but since working with this company, they hurt. I'm using brake parts cleaner and starting fluid. How will these chemicals affect me? Answer: The types of chemicals you describe typically result in a de-fatting of the skin, among other problems. This can make your hands turn red, itch, dry out and the skin split. The best thing to do to prevent this

problem is to utilize a good pair of gloves that will not break down when exposed to those chemicals. Since it sounds like damage has already been done to your hands, you should consider consulting with your physician for care/treatment.

SHARP Update

ADOSH offers employers the opportunity to be recognized for their efforts in promoting safe and healthful work environments. The Safety and Health Arizona Achievement Recognition Program (SHARP), started in 2004, recognizes employers that have demonstrated significant achievements in the area of workplace safety and health. Employers that have developed, implemented, and work to continuously improve the effectiveness of their workplace safety and health management policies, may be eligible for this program.



We are happy to announce that HOPE Research Institute recently received SHARP certification. In addition, two employers successfully completed SHARP re-certification; Imsamet of Arizona, in Goodyear, and 43rd Avenue Dental Care, in Phoenix.

Mushroom Rebar Caps

One year ago, ADOSH published a short article regarding mushroom style rebar caps. That article highlighted the fact that these types of caps are not designed to provide protection against impalement. Such use is warned against by the manufacturers of these caps.

Over the last 12 months, ADOSH personnel have made an effort to inform employers of this common misuse of the mushroom cap, while at the same time warn employers that ADOSH would begin issuing citations for this condition beginning January 1, 2007.

Starting January 1, 2007, ADOSH compliance officers will begin recommending citations when the mushroom style rebar cap is used as protection against impalement. These caps may still be used as protection against lacerations or scratches, as they were designed.

Fatal Mistakes

Each quarter, this column examines a workplace death, or a group of deaths, and attempts to show why these incidents occurred. We also try to make our readers understand what can be done to eliminate accidental death from the work place.

This quarter, we think it important to examine the raw statistics related to ADOSH involved workplace accidents. These facts cover six years of time from January 2000 to December 2005. During that time, there were 176 workplace deaths investigated by ADOSH. They breakdown as follows:

Citations issued as a result of ADOSH's investigations included 18 willful, 252 serious and 132 non-serious violations, and resulted in penalties totaling \$1,424,816.00, paid or payable. ADOSH collects and receives, but does not keep, this money. This money goes to the State's General Fund.

All accidents are preventable. These deaths could have been prevented by training, educating, monitoring, or closely controlling the environment where the employees were killed. At ADOSH, we want to help you eliminate workplace death and injury. Please use our consultative services, training classes, mentoring help and experience to work toward reducing and eliminating workplace death.

Regulatory Update

- 1. The 1910.1026 and 1926.1126, Hexavalent Chromium standards for both general industry and construction have been approved by the Attorney General's office, published by the Secretary of State and will become final on December 8, 2006.
- 2. 1926.754(c)(3) in the steel erection standard was deleted. This provided a requirement for the employer to provide slip resistant material to the beam surface during steel erection. This change will become final on December 8, 2006.
- 3. 1926.1000, Rollover Protective Structures, was amended to add new methods for manufacturers to test

- rollover protection to ensure protective standards are met. We anticipate the rule to be final February, 2007.
- 4. Some construction standard subparts (D Occupational Health and Environmental Controls, Z -Toxic and Hazardous Substances) and general industry subparts (I Personal Protective Equipment and Subpart Z Toxic and Hazardous Substances) are affected by the adoption of the new respiratory protection rules that identify "Assigned Protection Factors" and "Minimum Use Concentration" for respirators used to protect employees from exposure to hazardous substances. The rule will become final in late February, 2007.

ALERT!

Employee crushed by falling shed.

Over the past few months, we have received phone calls and e-mails regarding a company called *Compliance 4 Less*. We have been told that this company is making unannounced visits to workplaces, implying that they represent OSHA, and asking to check for the proper posters. Further, the representatives are claiming to "work with OSHA" or somehow partner with OSHA to ensure compliance.

ADOSH has no association with Compliance 4 Less, nor do we endorse companies trying to sell posters and other information that can be obtained, free of charge, from ADOSH.

Occupational Fatalities Investigated by ADOSH July 1, 2006 through September 30, 2006

- 1) An employee fell through a skylight.
- 2) An employee was crushed when an excavation side wall collapsed, burying him.
- 3) An employee stepped underneath the raised bucket of a front end loader. The loader operator was startled and inadvertently put the bucket into "float" position, dropping the bucket on the employee.
- 4) An employee was a victim of workplace violence when he was killed during a robbery attempt.
- 5) An employee was in the back of a delivery truck and was crushed by a load of large windows that fell from one side of the truck to the other.
- Two employees were injured, one fatally, when they fell through a sheet metal panel in a false ceiling, 40 feet to the floor.
- 7) An employee was crushed between a backhoe arm and an electrical vault when the backhoe fell into the vault.
- 8) One employee fell from a roof during decking installation.
- 9) A tree trimmer fell from a palm tree.
