Discussion & Action regarding Appointment of Special Assistant to the Industrial Commission of Arizona.

Alexander Love Sherinda Little

Ms. Tate requested to appoint Alexander Love and Sherinda Little as Special Assistants for the Commission's Claims Division and noted new positions.

Vice Chair Hennelly moved to appoint Alexander Love and Sherinda Little as Special Assistants and Commissioner Everett seconded the motion. Chairman Schultz, Vice Chair Hennelly and Commissioner Everett voted in favor or the motion. The motion passed.

# Announcements, Scheduling of Future Meetings and Retirement Resolutions.

Mr. Ashley noted that he met Ms. Little and Mr. Love during their training and welcomed them to the agency.

Mr. Ashley highlighted Governor Ducey's AZ Hires Vets program aimed at nearly doubling the number of veterans in the state workforce from 8.5% to 15% by 2025 and the planned Veterans Job Fair at Wesley Bolin Plaza on March 30, 2022. The Commission will have representatives from HR, ADOSH and Labor participating.

Chairman Schultz asked about the current number of veterans with the Commission, noting the Commission supports this effort. Mr. Ashley discussed how the Commission has several in the agency including ADOSH employees which includes several Elevator Inspectors.

Mr. Ashley discussed the VPP Audit for the Tucson Office which was just completed today with the assistance of two SGEs, Ryan Hubele with Johns Manville Manufacturing and Brent Hancock with Raytheon Missile Systems. Mr. Ashley noted that as of this afternoon, the Tucson Office was approved for VPP Star approval for three years and he would have more information at a later meeting.

Chairman Schultz noted it was generous of Johns Manville and Raytheon to share their employees.

Ms. Dimas confirmed Commission meeting dates through May 2022. Vice Chair Hennelly noted he may have a conflict with May 12 and 19.

#### Public Comment.

Ms. Shoemake thanked the Commissioners and Ms. Pastor for her hard work and support in helping them complete their renewal.

Chairman Schultz appreciates the effort it takes to put together a renewal packet and is consistently amazed with Ms. Pastor's commitment to the self-insureds and public entities to make sure they have every opportunity to present themselves in the best light.

Commissioner Everett moved to adjourn and Vice Chair Hennelly seconded the motion. Chairman Schultz, Vice Chair Hennelly and Commissioner Everett voted in favor of the motion and the meeting was adjourned at 1:18 p.m.
